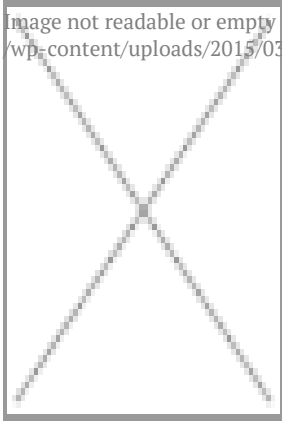

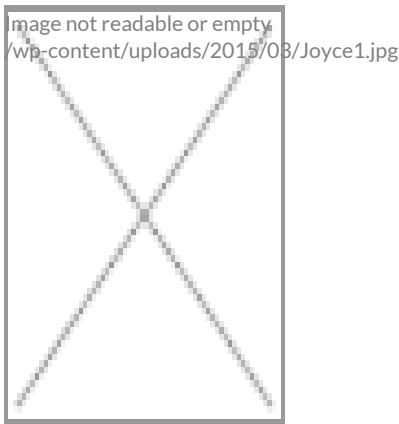

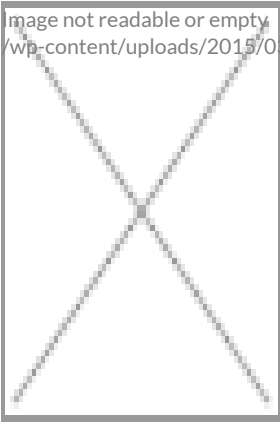
HorneKathleen Horne is an AV® Preeminent™ rated partner at the firm and practices primarily in the area of creditors

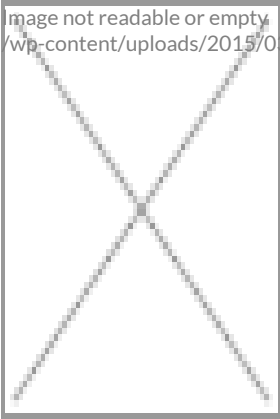

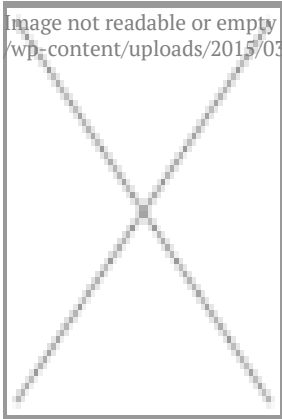

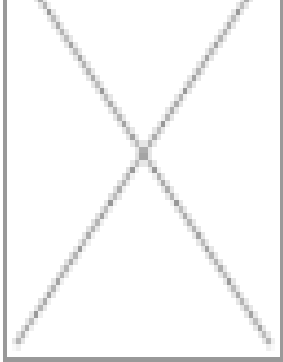
